- (iv) The holder of the licence shall from time to time report to the licensing authority any change in the premises where he carries on his business of sale. Export, import or storage for the said purpose seeds.
- (v) The licence shall give every facility to the licensing authority or any other officer acting under his authority for the purpose of inspecting his stock in any shop, depot or Godown or the place / places used by him for the purpose of storage, sale or export of seeds.
