
1. Licence shall come in force from 8.4.1999 and remain valid for 7.4.2001.

C O N D I T I O N

1. The licence shall be displayed in a prominent place in the part of the premises open to the public.
2. The licence shall comply with the provisions of the insecticides Act, 1968 and the rules made there under for the time being in force.
3. No sale of any insecticides shall be made to a person not holding a licence to sell, stock or exhibit for sale or distribute the insecticides.
4. Provided that the conditions shall not apply to the sale of any insecticides to an officer or authority purchasing on behalf of the Government.
5. An application for the renewal of a licence shall be made as laid down in rule II.
