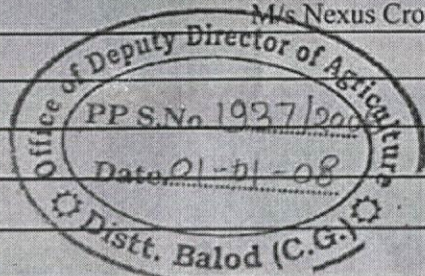





If the license wants to sell, stock or exhibited for sale or distributed or issued for in commercial pest control operation any additional insecticide during the validity of the license, he may apply to the licensing officer for issuance for each such insecticide on payment of the prescribed fee.
4. An application for the renewal of the license for pest operation shall be made as laid down in sub-rule (3A) of rule 10 of the insecticides rules, 1971.




